NOTICE IS HEREBY GIVEN that the County Council have made the above-named Order under Sections 1(1) 2(1) and (2), 82(2), 83(2) and 84 and Part III and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984.

The effect of the Order, which will come into force on the 9th April 2018 will be to extend the 30 miles per hour speed restrictions on sections of the following lengths of highway in Warkworth Village:

USRN	Street	Town	Description
00418260	U3043 ROAD TO WARKWORTH DUNES PICNIC SITE	WARKWORTH	For its entire length
00418107	C95 SEA VIEW SHILBOTTLE TO WARKWORTH	SHILBOTTLE	At its junction with Station Road Warkworth (grid ref: 424570 606337) to a point 443 metres west of its junction with Station Road Warkworth (grid ref: 424188 606524)
00403498	STATION ROAD	WARKWORTH	For its entire length

Exemptions are included in the Order for police, fire and rescue and ambulance purposes.

A copy of the Order, together with a map showing the area covered and a Statement of the Council's Reasons for Making the Order may be examined at Alnwick Information Centre, Greenwell Lane, Alnwick or by contacting the Programme and Production Team, Local Services Directorate, County Hall, Morpeth, Northumberland, NE61 2EF during normal office hours.

If you wish to question the validity of the Order or any of the provisions contained therein on the grounds that it is not within the powers conferred by the Road Traffic Regulation Act 1984 or on the grounds that any requirement of the Act or any instrument made under it has not been complied with in relation to the Order you may before the 18th May 2018 apply to the High Court for that purpose.

The Northumberland County Council, in exercise of their powers under Sections 1(1), 2(1) and (2), 82(2), 83(2) and 84 (1) and Part III and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984, hereby make the following order:

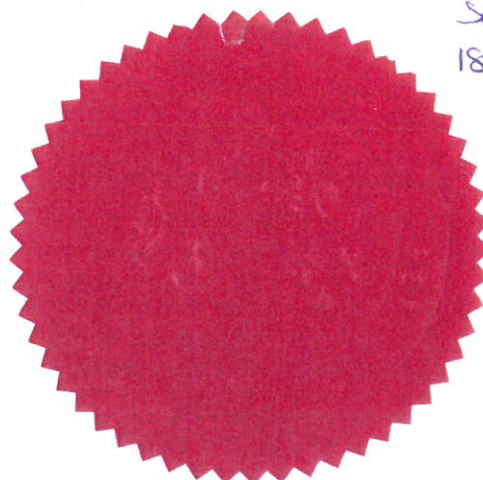
1. (1) This Order shall come into operation on the 9th April 2018 and may be cited as "The County of Northumberland (Warkworth Village (Extension) 30 MPH Speed Restriction) Order 2018."
 - (2) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
 - (3) Except where otherwise stated, any reference in this Order to a numbered article or schedule is a reference to the article or schedule bearing that number in this Order.
2. Save as provided in Article 3, this Order shall render it unlawful for a person to cause or permit a vehicle to proceed at a speed in excess of 30 mph on those lengths of highway detailed in Schedule 1.
 3. Nothing in Articles 1 and 2 shall make it unlawful for a person to drive in excess of the stated speed limit on the length of roads specified in that Article if it is being used for police, fire and rescue or ambulance purposes.
