ROAD TRAFFIC REGULATION ACT 1984 (WHALTON VILLAGE 20MPH and 30 MPH SPEED RESTRICTIONS) ORDER 2018 (TROM_124)

The Northumberland County Council, in exercise of their powers under Sections 82(2), 83(2) and 84 (1) and Part III and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, hereby make the following order:

- 1. (1) This Order shall come into operation on the 22nd October 2018 and may be cited as "The County Council of Northumberland (Whalton Village 20MPH and 30MPH Speed Restrictions) Order 2018."
 - (2) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
 - (3) Except where otherwise stated, any reference in this Order to a numbered article or schedule is a reference to the article or schedule bearing that number in this Order.
- 2. Save as provided in Articles 4 and 5 this Order shall render it unlawful for a person to cause or permit a vehicle to proceed at a speed in excess of 20 mph on those lengths of highway detailed in Schedule 1.
- 3. Save as provided in Articles 4 and 5 this Order shall render it unlawful for a person to cause or permit a vehicle to proceed at a speed in excess of 30 mph on those lengths of highway detailed in Schedule 2.
- 4. Nothing in Articles 1, 2 and 3 shall make it unlawful for a person to drive in excess of the stated speed limit on the length of roads specified in that Article if it is being used for police, fire and rescue or ambulance purposes.
- 5. Nothing in Articles 1, 2 and 3 shall make it unlawful for a person to drive in excess of the stated speed limit on the length of roads specified in that Article if the vehicle is being used by a member of the special forces and is being driven in response or for practice in responding to a national security emergency by a person who has been trained in driving vehicles at high speeds or for the purpose of training a person in driving vehicles at high speeds.
- 6. This Order will hereby revoke "The County of Northumberland, (Various Towns and Villages in Northumberland) (30MPH and 40 MPH Speed Restrictions) Order 2004, namely:-

Article 1 (d) Whalton

On the B6524 from the existing 30 mph termination point (approximately 170 metres west then southwards of its junction with the C154) in a south westerly direction for an approximate distance of 315 metres, and

ii. On the C358 from the existing 30 mph termination point (approximately 245 metres south then eastwards of its junction with the B6524) in an easterly then southerly direction for an approximate distance of 160 metres.


