NORTHUMBERLAND COUNTY COUNCIL ROAD TRAFFIC REGULATION ACT 1984 (COW ROAD SPITTAL 14'8"/5.6m LENGTH RESTRICTION) ORDER 2024 (TROM_307)

Northumberland County Council, in exercise of their powers under Sections 1, 2 and 4 and Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and of all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order:

- 1. (1) This Order shall come into operation on the 19th February 2024 and may be cited as "Northumberland County Council (Cow Road Spittal 14'8"/5.6m Length Restriction) Order 2024".
 - (2) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
 - (3) Except where otherwise stated, any reference in this Order to a numbered article or schedule is a reference to the article or schedule bearing that number in this Order.
- 2. Save as provided in Article 3, no person shall cause any vehicle with a length of, or in excess of 14'8"/5.6 metres, to proceed on the length of highway detailed in Schedule 1 to this Order.
- 3. Nothing in Articles 1 and 2 shall make it unlawful for a person to cause or permit a vehicle over the length of 14'8"/5.6 metres to proceed on the length of highway specified in Schedule 1, if it is being used for police, fire and rescue or ambulance purposes.


