NORTHUMBERLAND COUNTY COUNCIL ROAD TRAFFIC REGULATION ACT 1984 (NORHAM ROAD ASHINGTON ONE WAY TRAFFIC RESTRICTIONS) ORDER 2024 (TROM_313)

Northumberland County Council, in exercise of their powers under Sections 1, 2, 3 and 4 and Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order:

- (1) This Order shall come into operation on the 30th September 2024 and may be cited as "Northumberland County Council (Norham Road Ashington One Way Traffic Restrictions) Order 2024."
 - (2) The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
 - (3) Except where otherwise stated, any reference in this Order to a numbered article or schedule is a reference to the article or schedule bearing that number in this Order.
 - (4) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
- 2. Save as provided in Article 4, no person shall cause or permit any vehicle with an exemption for bicycles to proceed in any specified length of highway in a direction other than that specified in relation to that length of highway as shown in Schedule 1 of this Order.
- 3. Save as provided in Article 4, no person shall cause or permit any vehicle to proceed in any specified length of highway in a direction other than that specified in relation to that length of highway as shown in Schedule 2 of this Order.
- 4. Nothing in Articles 2 and 3 shall make it unlawful to cause or permit any vehicle to proceed on those lengths of highway detailed in Schedule 1 and 2, if the vehicle is being used for fire and rescue, police, ambulance or special forces purposes.
- 5. This Order will hereby revoke 'Norham Road, Ashington At its junction with Newbiggin Road to a point 6 metres south of its junction with Haydon Road' of Schedule 1 in "Northumberland County Council (Ashington One Way & No Entry Traffic Restrictions) Order 2023".


