

**NORTHUMBERLAND COUNTY COUNCIL  
ROAD TRAFFIC REGULATION ACT 1984  
(B6525 DODDINGTON 30 MPH SPEED RESTRICTION)  
ORDER 2025 (TROM\_321)**

**NOTICE IS HEREBY GIVEN** that Northumberland County Council have made the above-named Order under Sections 81 to 84 and Part III and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of the Order, which will come into force on the 20<sup>th</sup> January 2025 will be to introduce a 30 miles per hour speed restriction on the following lengths of highways in the County of Northumberland:-

2518934	B6525 DODDINGTON TO BARMOOR	BERWICK- UPON- TWEED	At its junction with B6525 Doddington Village to a point 132 metres north of its junction with B6525 Doddington Village	399903, 632620 to 399883, 632741
2518933	B6525 DODDINGTON VILLAGE	WOOLER	At its junction with B6525 Doddington To Barmoor to a point 111 metres south of the U1035 Doddington Back Loop Road Through Village road	399903, 632620 to 399885, 632263

Exemptions are included in the Order for police, fire and rescue, ambulance and special forces purposes.

This Order will hereby revoke all previous Orders or sections of Orders detailing speed limits on the lengths of highways specified in the Schedule of this Order.

If you wish to question the validity of the Order or any of the provisions contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any relevant regulations made thereunder have not been complied with in relation to the Order you may within 6 weeks from the date on which the Order was made apply to the High Court for that purpose.
