

**NORTHUMBERLAND COUNTY COUNCIL
ROAD TRAFFIC REGULATION ACT 1984
(A1171 DUDLEY LANE & B1505 VALLEY PARK TO KLONDYKE CRAMLINGTON
40 MPH SPEED RESTRICTION) ORDER 2025
(TROM_324)**

NOTICE IS HEREBY GIVEN that Northumberland County Council have made the above-named Order under Sections 81 to 84 and Part III and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of the Order, which will come into force on the 3rd February 2025 will be to introduce a 40 miles per hour speed restriction on the following lengths of roads in Cramlington in the County of Northumberland:-

USRN	Street	Town	Description
3201264	DUDLEY LANE	CRAMLINGTON	At a point 190 metres south west of its junction with the Access Road To Cramlington Learning Village road to its junction with Dudley Lane (Dudley)
3218992	A1171 VALLEY PARK TO DUDLEY LANE	CRAMLINGTON	For its entire length
3218991	A1171 VALLEY PARK ROUNDABOUT	CRAMLINGTON	For its entire length
3219004	B1505 VALLEY PARK TO KLONDYKE	CRAMLINGTON	At its junction with B1505 Klondyke to its junction with A1171 Valley Park Roundabout

Exemptions are included in the Order for police, fire and rescue, ambulance and special forces purposes.

This Order will hereby revoke all previous Orders or sections of Orders detailing speed limits on the lengths of roads specified in the Schedule of this Order.

If you wish to question the validity of the Order or any of the provisions contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any relevant regulations made thereunder have not been complied with in relation to the Order you may within 6 weeks from the date on which the Order was made apply to the High Court for that purpose.
