#### 1. **Commencement and Citation**

This Order shall come into operation on the 16<sup>th</sup> July 2018 and may be cited as "Northumberland County Council North Northumberland (Central) Area (Parking Places) Composite Order 2011 - Amendment No 19 Order 2018".

#### 2. In the Order:-

"Order" means "Northumberland County Council North Northumberland (Central) Area (Parking Places) Composite Order 2011".

"Amendment Order" means "Northumberland County Council North Northumberland (Central) Area (Parking Places) Composite Order 2011- Amendment No 19 Order 2018".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.
