The effect of the above will be to make permanent the following Experimental Order in accordance with Regulation 23, "The Local Authorities" Traffic Orders (Procedure) (England and Wales) Regulations 1996.

"NCC North Northumberland (Central) Area (Parking Places) Composite Order 2011 - Amendment No 17 Experimental Order 2017"

The general effect of this Order is to improve parking for residents and reduce congestion on Argyle Street in Alnmouth.
