## 1. Commencement and Citation

This Order shall come into operation on the 28 January 2021 and may be cited as "Northumberland County Council North Northumberland (Northern) Area (Waiting and Loading) Composite Order 2011 - Amendment No 46 Order 2021".

#### 2. In the Order:-

"Order" means "Northumberland County Council North Northumberland (Northern) Area (Waiting and Loading) Composite Order 2011".

"Amendment Order" means "Northumberland County Council North Northumberland (Northern) Area (Waiting and Loading) Composite Order 2011- Amendment No 46 Order 2021".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.
