Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2 and 4 and Paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

**1. Commencement and Citation**

This Order shall come into operation on the 30<sup>th</sup> November 2020 and may be cited as "Northumberland County Council West Northumberland Area (Waiting and Loading) Composite Order 2011 – Amendment No 67 Order 2020".

**2. In the Order:-**

"Order" means "Northumberland County Council West Northumberland Area (Waiting and Loading) Composite Order 2011".

"Amendment Order" means "Northumberland County Council West Northumberland Area (Waiting and Loading) Composite Order 2011 – Amendment No 67 Order 2020".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

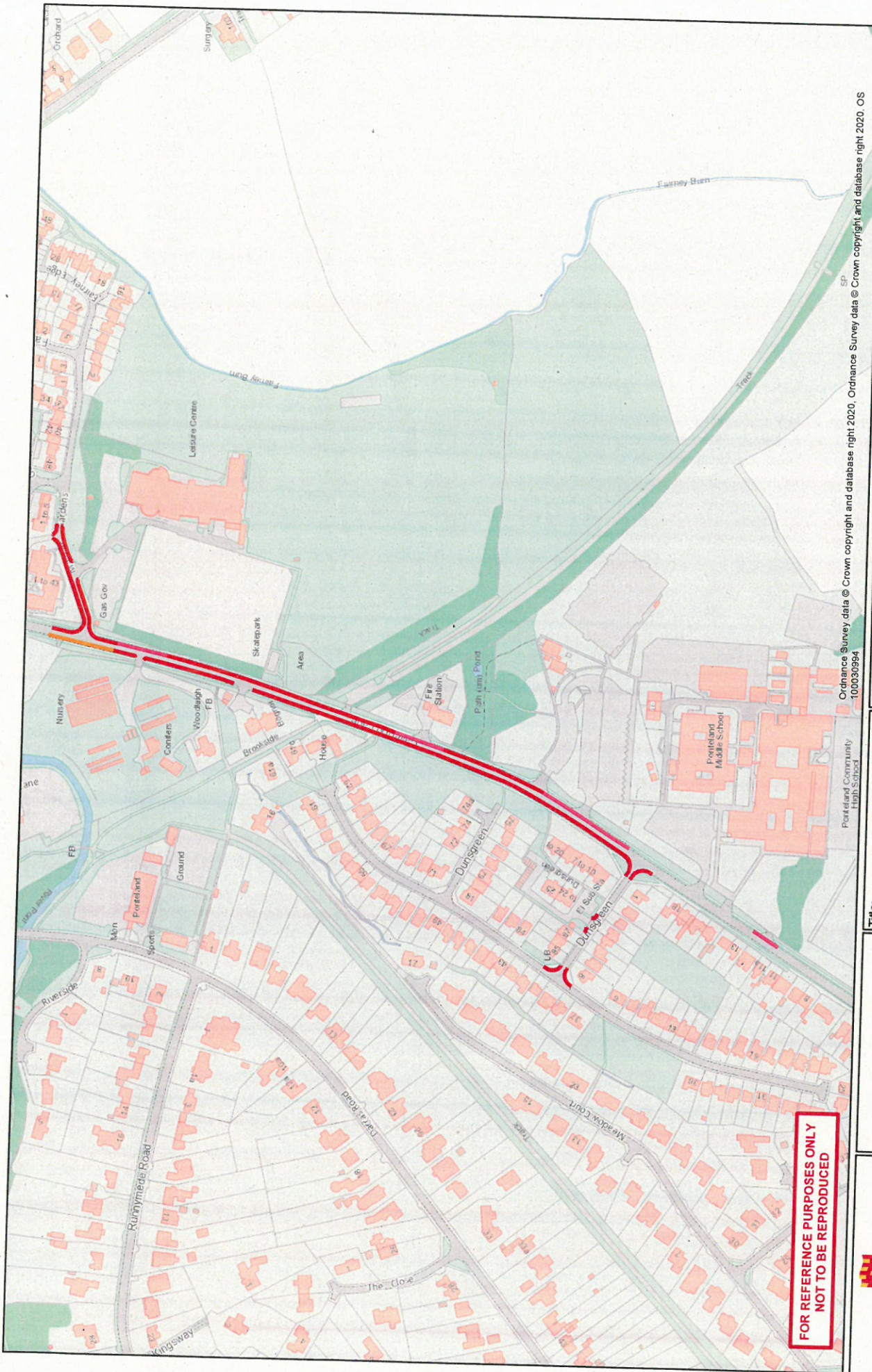

**STATEMENT OF THE COUNCIL'S REASONS FOR  
MAKING THE ORDER**

Callerton Lane, Ponteland


The Order is necessary to improve road safety outside the leisure centre, school and fire station on Callerton Lane, Ponteland. 'Keep Clear' zig-zag markings are intended to ensure that all accesses and entrances remain clear of vehicles, whilst 'No Waiting' restrictions are required in order to prevent obstructive parking and improve the flow of traffic as well as visibility for pedestrians, cyclists and motorists.
