Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2, 4, 32, 35, 45, 46 and Part IV 4 of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

**1. Commencement and Citation**

This Order shall come into operation on the 24<sup>th</sup> May 2021 and may be cited as "Northumberland County Council West Northumberland Area (Parking Places) Composite Order 2011 – Amendment No 28 Order 2021".

**2. In the Order:-**

"Order" means "Northumberland County Council West Northumberland Area (Parking Places) Composite Order 2011".

"Amendment Order" means "Northumberland County Council West Northumberland Area (Parking Places) Composite Order 2011 – Amendment No 28 Order 2021".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

### 3. Provisions

The following provisions set out below and in The Schedule to this Amendment Order shall be additions to, deletions from, or substitutions in the restrictions in the Order:

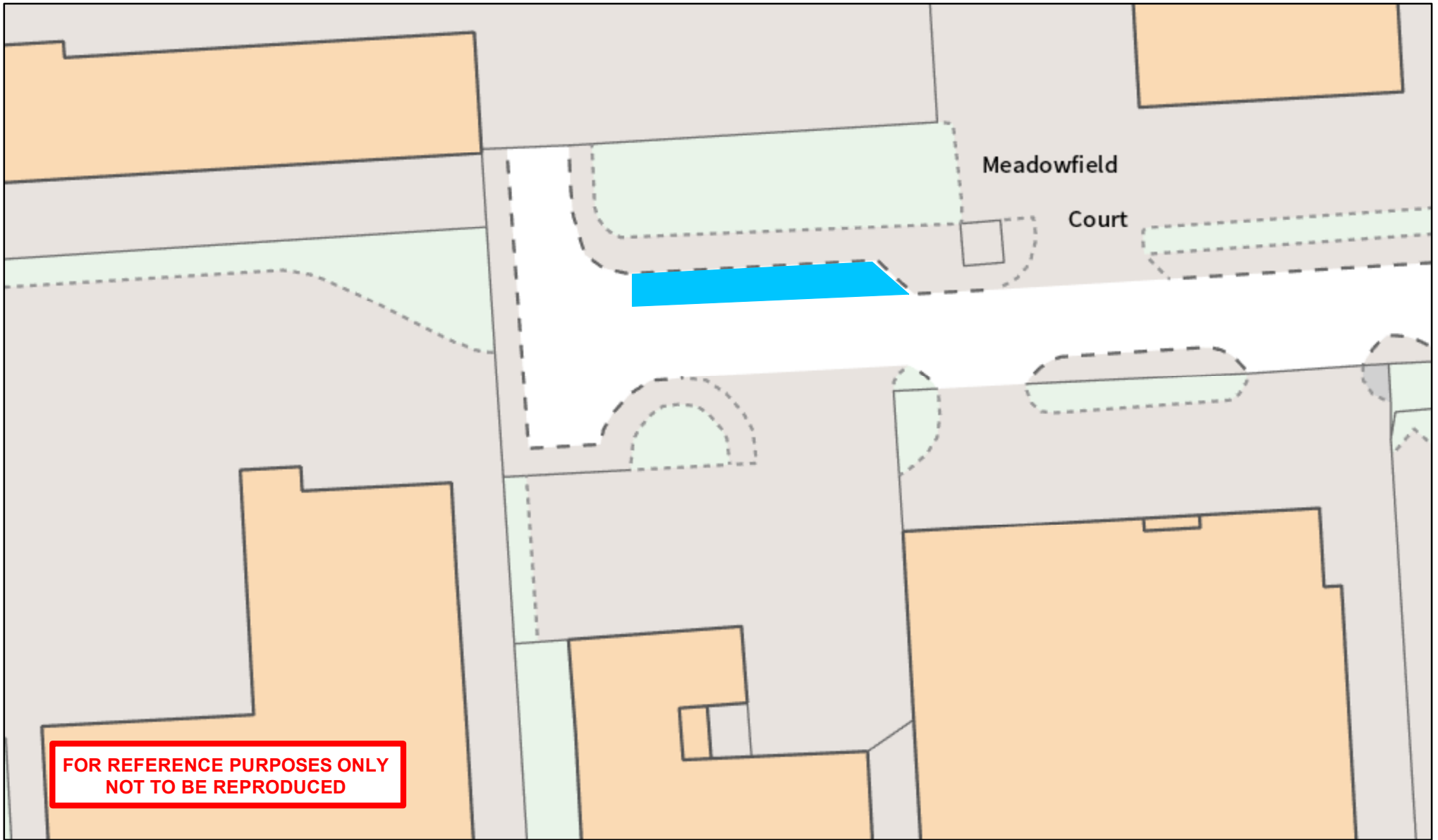
