Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2 and 4 and Paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

1. Commencement and Citation

This Order shall come into operation on the 20th September 2021 and may be cited as "Northumberland County Council South East Northumberland Area (Waiting and Loading) Composite Order 2011 – Amendment No 106 Order 2021".

2. In the Order:-

"Order" means "Northumberland County Council South East Northumberland Area (Waiting and Loading) Composite Order 2011".

"Amendment Order" means "Northumberland County Council West Northumberland Area (Waiting and Loading) Composite Order 2011 – Amendment No 106 Order 2021".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

**STATEMENT OF THE COUNCIL'S REASONS FOR
MAKING THE ORDER**

Plessey Woods, Hartford Bridge

The Order is necessary to improve road safety by prohibiting obstructive and indiscriminate parking often associated with visitors to Plessey Woods Country Park at Hartford Bridge. The existing off-street car parks within the Country Park can often be at full capacity or motorists avoid the Pay & Display parking charges and park on the A192 Shields Road, which creates congestion, reduced visibility, extra footfall with no formal crossing facilities available, obstructed footways forcing pedestrians onto the carriageway and moving traffic having difficulties navigating through the vicinity, therefore these new waiting restrictions are required.
