1. Commencement and Citation

This Order shall come into operation on the 6th December 2021 and may be cited as "Northumberland County Council South East Northumberland Area (Waiting & Loading) Composite Order 2011 - Amendment No 109 Order 2021".

"Order" means "Northumberland County Council South East Northumberland Area (Waiting & Loading) Composite Order 2011".

"Amendment Order" means "Northumberland County Council South East Northumberland Area (Waiting & Loading) Composite Order 2011- Amendment No 109 Order 2021".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.






