## STATEMENT OF THE COUNCIL'S REASONS FOR MAKING THE ORDER

Seaton Sluice Middle School, Seaton Sluice

The Order is necessary to improve road safety by prohibiting obstructive and indiscriminate parking on St. Ronan's Drive during school start and end times, whilst also preventing parking at the associated junctions with Alston Grove and Astley Villas at all times. The measures are to be introduced as part of the new School Streets initiative on Alston Grove in order to encourage reduced vehicle usage and an increase in active travel when travelling to and from schools.
