Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 1, 2 and 4 and Paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

**1. Commencement and Citation**

This Order shall come into operation on the 12<sup>th</sup> June 2023 and may be cited as "Northumberland County Council South East Northumberland Area (Waiting and Loading) Composite Order 2011 – Amendment No 124 Order 2023".

**2. In the Order:-**

"Order" means "Northumberland County Council South East Northumberland Area (Waiting and Loading) Composite Order 2011".

"Amendment Order" means "Northumberland County Council South East Northumberland Area (Waiting and Loading) Composite Order 2011 – Amendment No 124 Order 2023".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

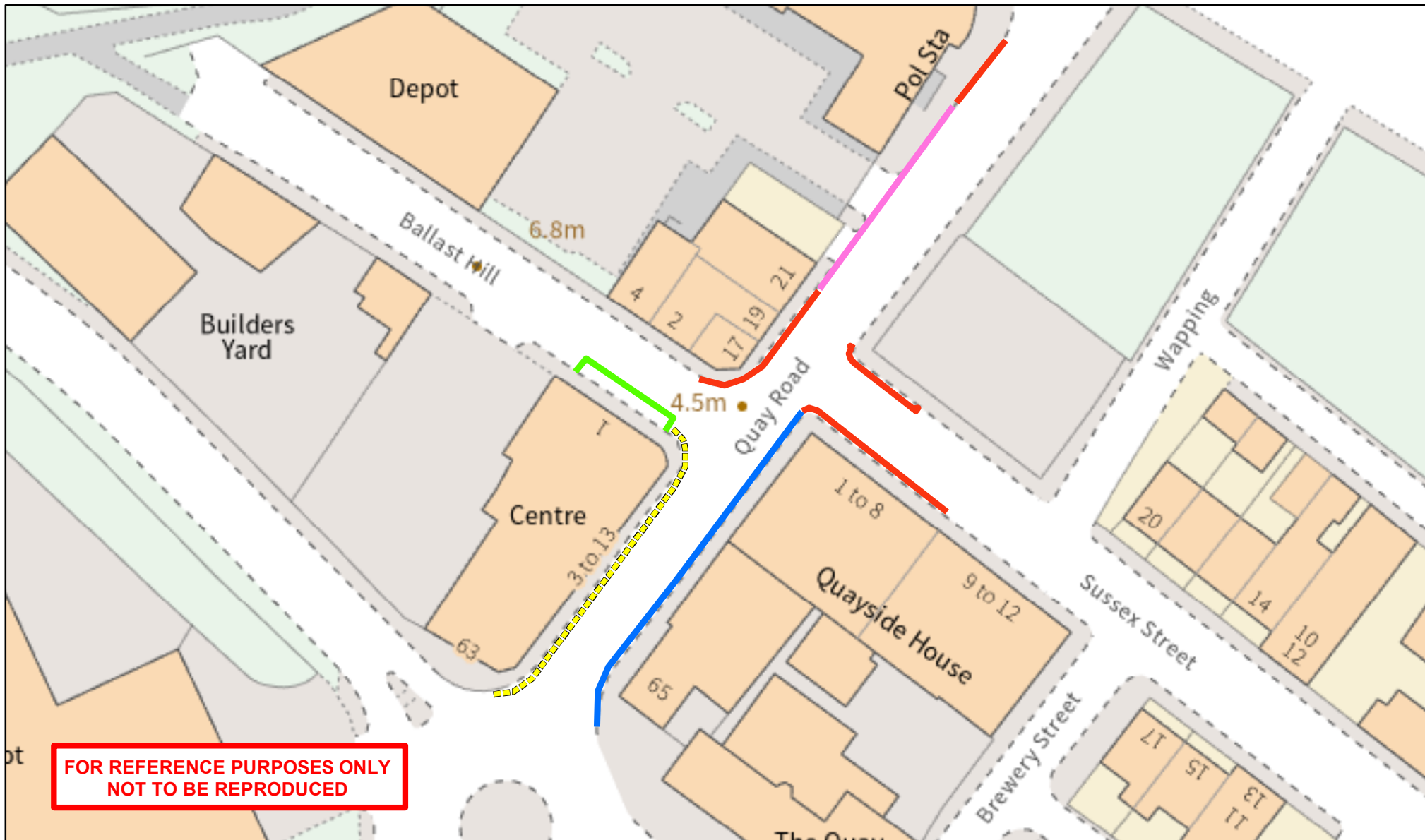

**STATEMENT OF THE COUNCIL'S REASONS FOR  
MAKING THE ORDER**

Quay Road & Ballast Hill, Blyth

The Order is necessary to improve road safety by prohibiting obstructive and indiscriminate parking on Quay Road in Blyth by introducing waiting and loading restrictions to apply at all times. These restrictions are required to maintain the free flow of traffic, especially for emergency services situated in the area, whilst also providing loading facilities for local businesses.
