Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 32, 35 and Paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

1. Commencement and Citation

This Order shall come into operation on the 15th October 2018 and may be cited as "Northumberland County Council Off Street Parking Places Composite Order 2014 Amendment No 10 Order 2018"

2. In the Order:-

"Order" means "Northumberland County Council Off Street Parking Places Composite Order 2014"

"Amendment Order" means "Northumberland County Council Off Street Parking Places Composite Order 2014 Amendment No 10 Order 2018"

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

3. Provisions

The following provisions set out below and in The Schedule to this Amendment Order shall be additions to, deletions from, or substitutions in the restrictions in the Order:

to Part 1 - Preliminary 2. Interpretation

ADDITION - **"Special Permit"** means as permit issued by the Council under provisions of Article 7 as defined in Schedule 3 of this Order;

DELETION - **"Temporary Permit"** means as permit issued by the Council under provisions of Article 7 as defined in Schedule 3 of this Order;

to Part II - Use of Land and Parking Place

ADDITION - 5. Restrictions of Parking Places (x)

Where, in a Parking Place, there is a sign or surface marking which indicates that a parking bay or part of the Parking Place is available only for a Disabled Person's Vehicle, HGV, motor cycle, cycle, motorhome, coach, car club vehicle, electric vehicle, the Driver of a vehicle shall not permit it to wait in that parking bay or that part of the Parking Place (as the case may be) unless it is either that class of vehicle or in the case of a disabled persons vehicle it displays a valid disabled persons badge.

DELETION - 5. Restrictions of Parking Places (x)

Where, in a Parking Place, there is a sign or surface marking which indicates that a parking bay or part of the Parking Place is available only for a Disabled Person's Vehicle, the Driver of a vehicle shall not permit it to wait in that parking bay or that part of the Parking Place (as the case may be) unless it is a Disabled Person's Vehicle.

ADDITION - 5. Restrictions of Parking Places (xiii)

Notwithstanding the provisions of Article 5 (xi) a vehicle drawing a trailer may occupy two Parking Bays or Parking Places provided that the Driver displays a valid Parking Ticket for each Parking Place or Parking Bay occupied by the vehicle and trailer, or in a free car park, a vehicle may occupy two Parking Bays or Parking Places provided that the vehicle exceeds the length of Parking Bays or Parking Places and is permitted to park by Schedule 1 Column 6 – Class of Vehicle.

DELETION - 5. Restrictions of Parking Places (xiii)

Notwithstanding the provisions of Article 5 (xi), if a vehicle is of a size that it can only safely occupy two Parking Bays or Parking Places (or parts thereof), then the Driver shall be permitted to leave the vehicle therein provided that a valid parking ticket for each Parking Bay or Parking Place is displayed.

ADDITION - 7. Parking Permits (i)(b) Special Permit

DELETION- 7. Parking Permits (i)(b) Temporary Permit

ADDITION - 8. Display of Parking Discs - Limited Stay Parking Places, Maximum Stay and Return Times (v)

Subject to the provisions of Articles 17 & 18, the Driver shall, on the arrival of the Motor Vehicle at any Parking Place specified in Schedule 1 during the Restriction Hours as specified in column 10 of Schedule 1 exhibit on the Motor Vehicle in accordance with the following provisions of this Article a Parking Disc.

DELETION - 8. Display of Parking Discs - Limited Stay Parking Places, Maximum Stay and Return Times (v)

Subject to the provisions of Articles 17 & 18, the Driver shall, on the arrival of the Motor Vehicle at any Parking Place specified in Schedule 1 during the Restriction Hours as specified in Column 9 of Schedule 2 exhibit on the Motor Vehicle in accordance with the following provisions of this Article a Parking Disc;

ADDITION - 8. Display of Parking Discs - Limited Stay Parking Places, Maximum Stay and Return Times (ix)

When a Parking Disc exhibited in pursuance of this Part of this Order is showing an exact quarter hour, then that time, or where the indicated time of arrival is not shown as an exact quarter hour, then the next Quarter Hour Period indicated on a Parking Disc, as the case may be, shall be deemed to be that the Motor Vehicle has been waiting in that Parking Place since that time, in any proceedings for a contravention of Article 8 (iii) of this Order.

DELETION - 8. Display of Parking Discs - Limited Stay Parking Places, Maximum Stay and Return Times (ix)

When a Parking Disc exhibited in pursuance of this Part of this Order is showing an exact quarter hour, then that time, or where the indicated time of arrival is not shown as an exact quarter hour, then the next Quarter Hour Period indicated on a Parking Disc, as the case may be, shall be treated as evidence that the Motor Vehicle has been waiting in that Parking Place since that time, in any proceedings for a contravention of Article 8 (iii) of this Order.

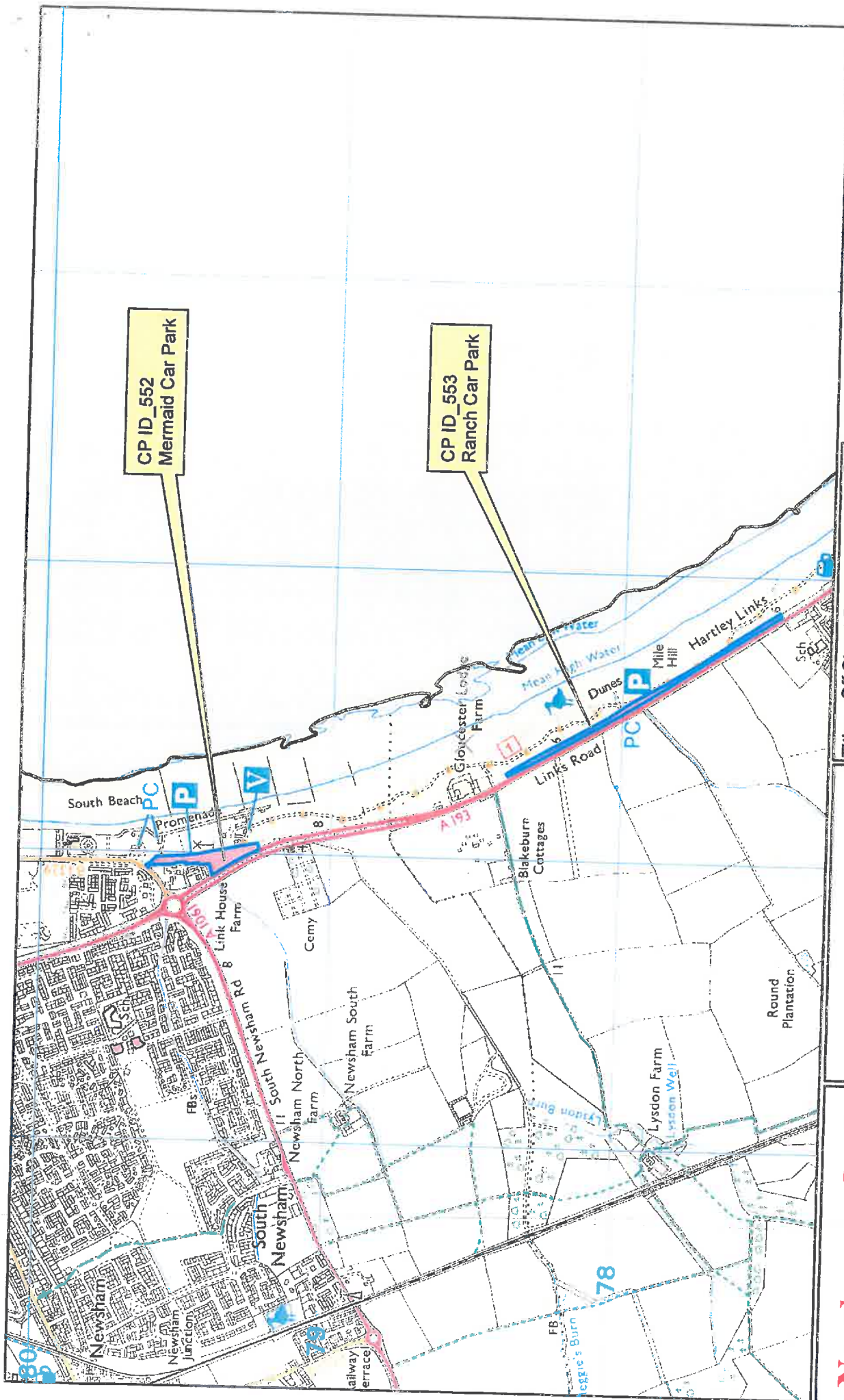

Making the Order

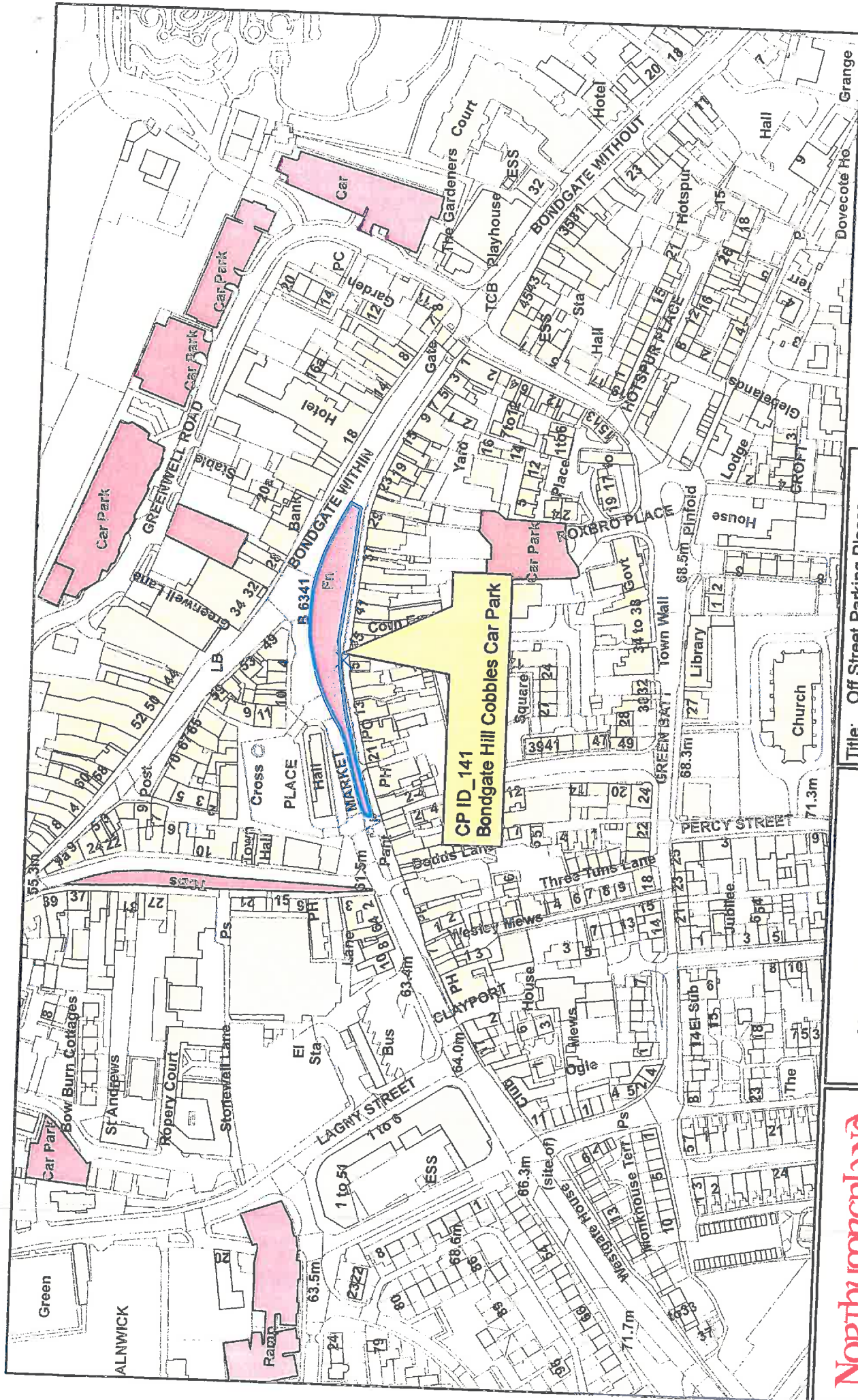

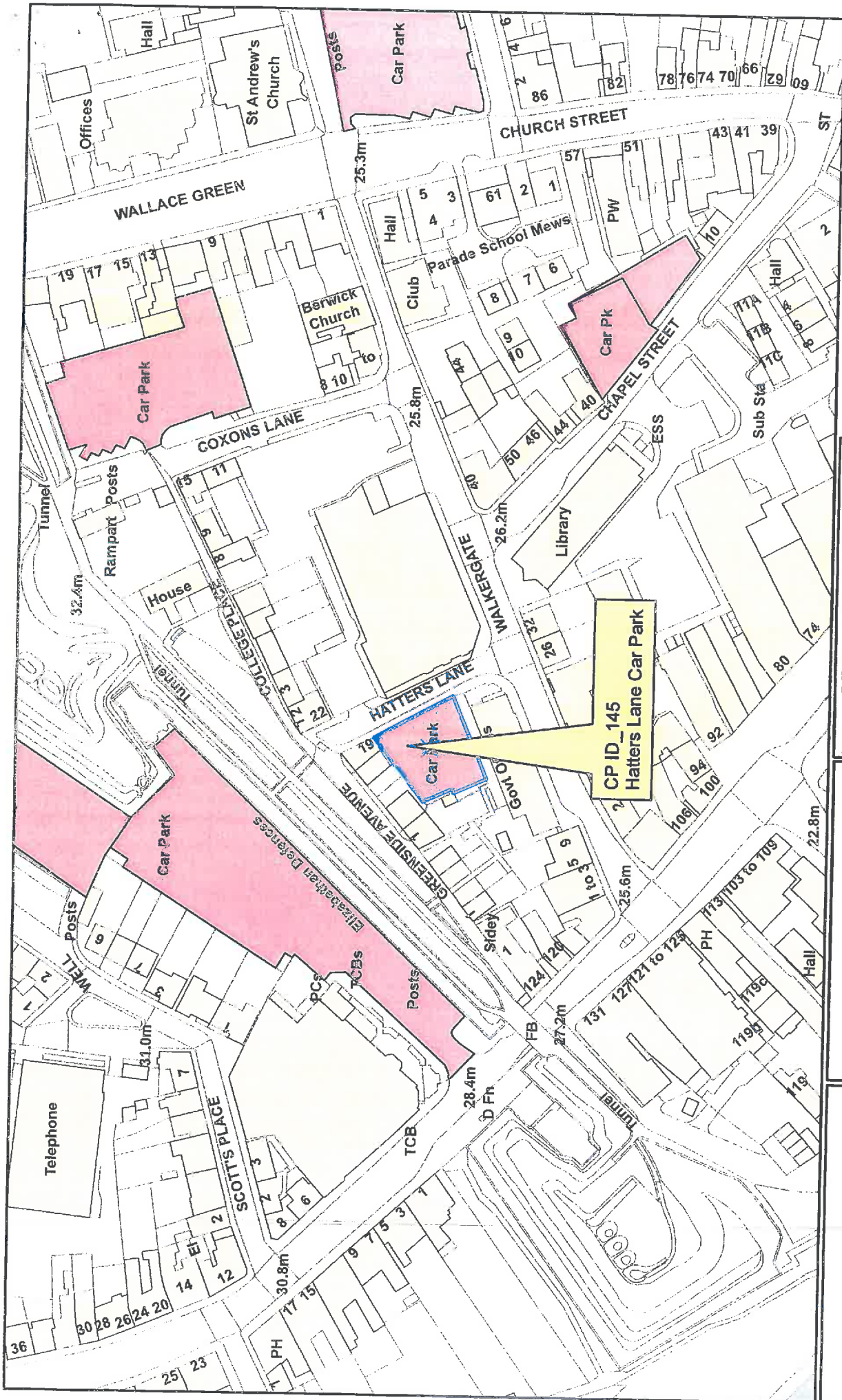

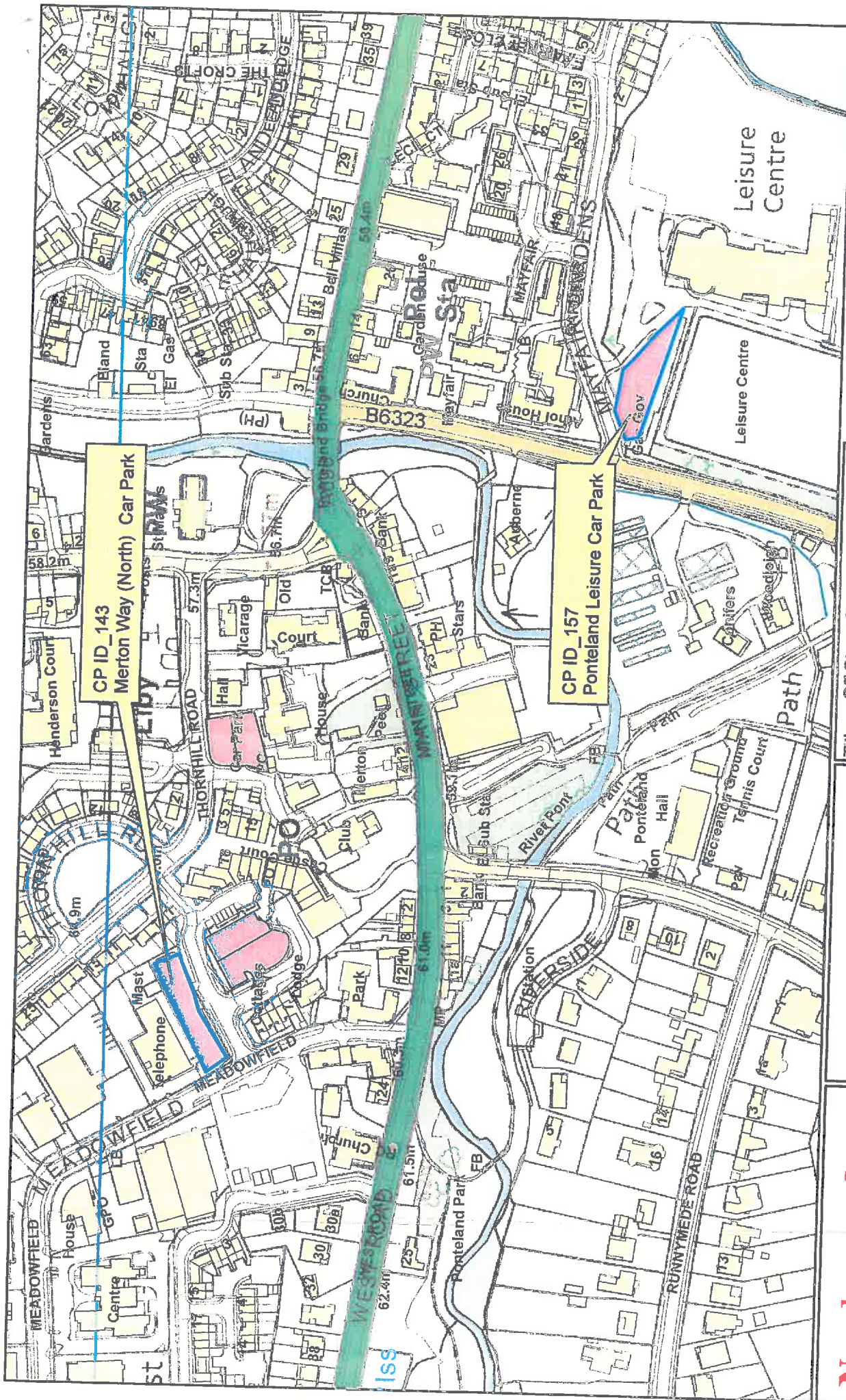
