Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 32 and 35 and Part III and Part of IV Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), Part 6 of the Traffic Management Act 2004 ("the Act of 2004"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

1. Commencement and Citation

This Order shall come into operation on the 7th November 2022 and may be cited as "Northumberland County Council Off Street Parking Places Composite Order 2014 – Amendment No 17 Order 2022".

2. In the Order:-

"Order" means "Northumberland County Council Off Street Parking Places Composite Order 2014".

"Amendment Order" means "Northumberland County Council Off Street Parking Places Composite Order 2014 – Amendment No 17 Order 2022".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

3. Provisions

The following provisions set out below and in The Schedule to this Amendment Order shall be additions to, deletions from, or substitutions in the restrictions in the Order:

(A) Additions

to Schedule 1 – Off Street Parking Places

(Referenced in this Amendment Order as: First Schedule – ADDITIONS)

to Schedule 1 – Off Street Parking Places

(Referenced in this Amendment Order as: Second Schedule – DELETIONS)

(C) Substitutions

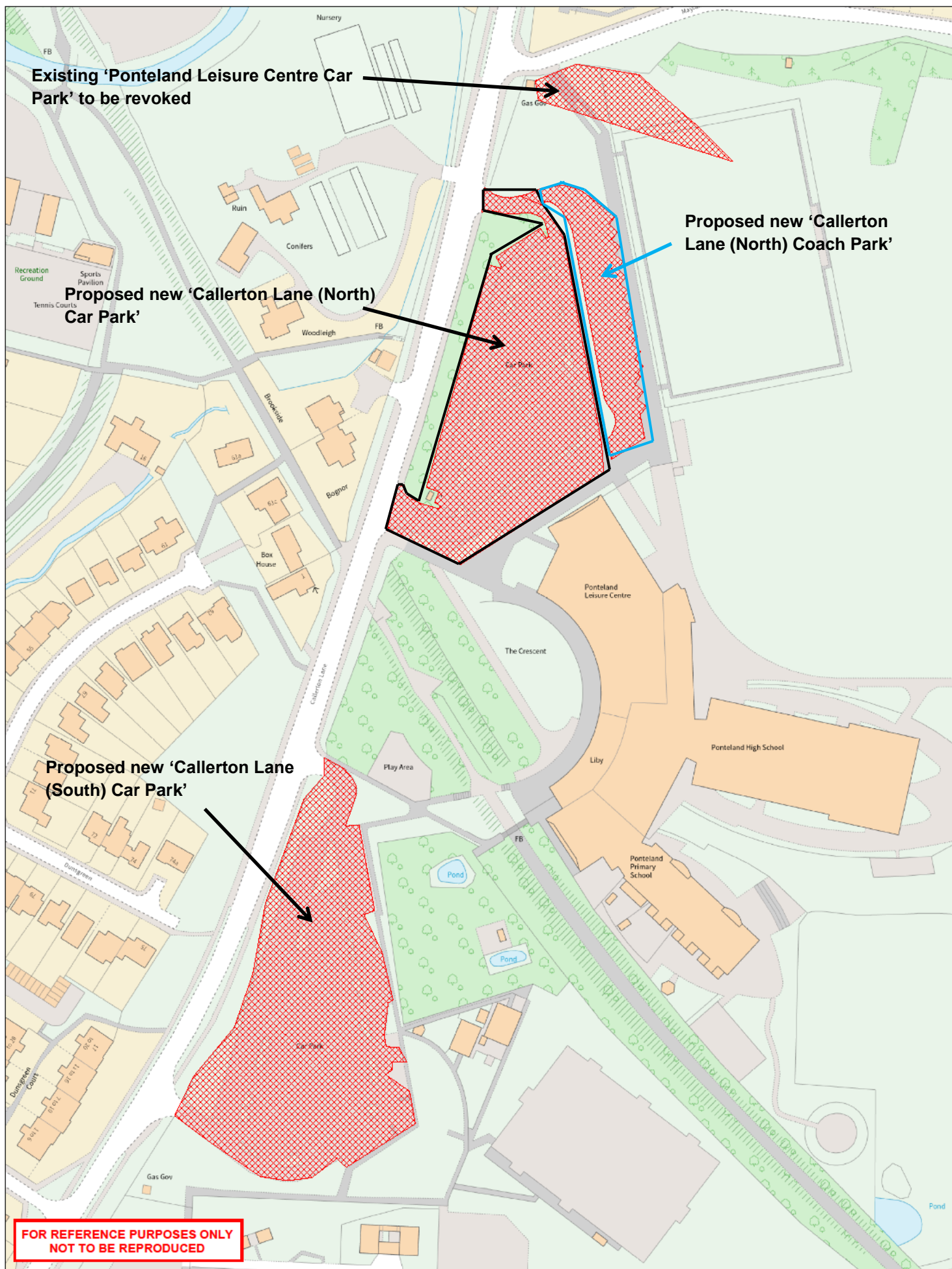

**STATEMENT OF THE COUNCIL'S REASONS FOR
MAKING THE ORDER**

Ponteland Schools & Leisure Centre Off-Street Car Parks

The Order is necessary so that enforcement of the identified car parks can be carried out by the County Council and Penalty Charge Notices issued to vehicles observed to be parking outside of the marked bays provided. A section of the northern car park is to be split into an off-street car park designated for coaches only in order to allow for buses to continue to pick-up and drop-off schoolchildren during school start and end times, along with other coaches associated with the Leisure Centre which may need to use the facility. The old 'Ponteland Leisure Centre' car park, which was removed as part of the recent new development and replaced by two new off-street car parks, is to be subsequently revoked from the Order.
