(OFF STREET PARKING PLACES – Ref: TRO\_019\_22):- **NOTICE** IS HEREBY GIVEN that Northumberland County Council will on 14<sup>th</sup> April 2023 under Section 35C and Parts I and V of the Road Traffic Regulation Act 1984 (as amended) and the Local Authorities' Traffic Order (Procedure) (England and Wales) Regulations 1996 vary the off street parking charges in Bamburgh, Beadnell, Craster, Holy Island, Newton-by-the-Sea and Seahouses in Northumberland as specified in the Schedule to the above-mentioned Order.

The variation to the charges will come into force on 14<sup>th</sup> April 2023. For those charges that are being varied, the existing and new charges are set out below:
