Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 32 and 35 and Part III and Part of IV Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), Part 6 of the Traffic Management Act 2004 ("the Act of 2004"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-

1. Commencement and Citation

This Order shall come into operation on the 28th May 2024 and may be cited as "Northumberland County Council Off Street Parking Places Composite Order 2014 – Amendment No 22 Order 2024".

2. In the Order:-

"Order" means "Northumberland County Council Off Street Parking Places Composite Order 2014".

"Amendment Order" means "Northumberland County Council Off Street Parking Places Composite Order 2014 – Amendment No 22 Order 2024".

The Interpretation Act 1978 shall apply to this Order as it applies to an Act of Parliament.

3. Provisions

The following provisions set out below and in The Schedule to this Amendment Order shall be additions to, deletions from, or substitutions in the restrictions in the Order:

5. Restrictions of Parking Places (x)

Where, in a parking place, there is a sign or surface marking which indicates that a parking bay or part of the parking place is available only for a disabled persons' vehicle, HGV, motorcycle, cycle, motorhome, coach, car club vehicle, electric vehicle or licensed taxi, the driver of a vehicle shall not permit it to wait in that parking bay or that part of the parking place (as the case may be) unless it is a disabled persons' vehicle, either that class of vehicle or in the case of a disabled persons' vehicle it displays a valid disabled persons' badge.

Ashington Railway Station Car Park, Ashington

The Order is necessary so that new parking facilities can be implemented and enforced in association with the opening of the Northumberland Line and Ashington Station. Additional long-stay limited waiting restrictions are to be created at Ashington Railway Station Car Park for commuters accessing the new trainline, whereas reduced short-stay limited waiting restrictions will continue to be in place at Station Yard Short Stay Car Park.
