- i. The maps which form the map-based Schedule of the "Northumberland County Council (Waiting, Loading & Parking Places) (Map Based) Consolidation Order 2024 Variation Order 06" are to be read in conjunction with this Order and depict the extent and types of restrictions as required by this Order.
- ii. The "Northumberland County Council (Waiting, Loading & Parking Places) (Map Based) Consolidation Order 2024" is hereby varied and will include the maps which form the Schedule to this Order.


Statement of Reasons




