

ROAD TRAFFIC REGULATION ACT 1984

(WAITING, LOADING & PARKING PLACES) (MAP BASED)
CONSOLIDATION ORDER 2024 VARIATION ORDER 19
(TRO_101_19)

Notice is hereby given that Northumberland County Council, in exercise of the powers conferred under sections 1 to 4, 32, 35, 45 and 46, 61 and 64 (as appropriate) and Part IV of schedule 9 of the Road Traffic Regulation Act 1984, the Traffic Management Act 2004 and all other powers so enabling, has made the above-named Order.

The effect of the Order, which will come into force on the 24th March 2025 will be to vary the "Northumberland County Council (Waiting, Loading & Parking Places) (Map Based) Consolidation Order 2024" by extending the following parking restrictions in Blyth:

'No waiting at any time' (double yellow lines) on Briarwood Road, Dent Street, Grantham Street and Twizell Street.

The effect of the Order, which will come into force on the 24th March 2025 will be to vary the "Northumberland County Council (Waiting, Loading & Parking Places) (Map Based) Consolidation Order 2024" to remove the following parking restrictions in Blyth:

'No waiting at any time' (double yellow lines) on Wensleydale Terrace, between property numbers 177 and 193.

The restrictions can also be viewed in map format, as the maps form part of the map-based schedule to the Order. A copy of the Order, together with the maps that form part of the Schedule to the Order and any other relevant documents, notices or Orders as appropriate as well as a Statement of the Council's reasons for making the Order are available to view or download on the NCC Website:

If you wish to question the validity of the Order or any of the provisions contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any relevant regulations made thereunder have not been complied with in relation to the Order you may within 6 weeks from the date on which the Order was made apply to the High Court for that purpose.
