## ROAD TRAFFIC REGULATION ACT 1984 NORTHUMBERLAND COUNTY COUNCIL (WAITING, LOADING & PARKING PLACES) (MAP BASED) CONSOLIDATION ORDER 2024 VARIATION ORDER 19 (TRO\_101\_19)

Notice is hereby given that Northumberland County Council, in exercise of the powers conferred under sections 1 to 4, 32, 35, 45 and 46, 61 and 64 (as appropriate) and Part IV of schedule 9 of the Road Traffic Regulation Act 1984, the Traffic Management Act 2004 and all other powers so enabling, has made the above-named Order.

The effect of the Order, which will come into force on the 24<sup>th</sup> March 2025 will be to vary the "Northumberland County Council (Waiting, Loading & Parking Places) (Map Based) Consolidation Order 2024" by extending the following parking restrictions in Blyth:

'No waiting at any time' (double yellow lines) on Briarwood Road, Dent Street, Grantham Street and Twizell Street.

The effect of the Order, which will come into force on the 24<sup>th</sup> March 2025 will be to vary the "Northumberland County Council (Waiting, Loading & Parking Places) (Map Based) Consolidation Order 2024" to remove the following parking restrictions in Blyth:

'No waiting at any time' (double yellow lines) on Wensleydale Terrace, between property numbers 177 and 193.

If you wish to question the validity of the Order or any of the provisions contained therein on the grounds that it is not within the relevant powers of the Road Traffic Regulation Act 1984 or that any of the relevant requirements thereof or of any relevant regulations made thereunder have not been complied with in relation to the Order you may within 6 weeks from the date on which the Order was made apply to the High Court for that purpose.
