NORTH NORTHUMBERLAND (NORTHERN) AREA (WAITING & LOADING)
COMPOSITE ORDER 2011
AMENDMENT NO 45 ORDER 2020**

(WAITING AND LOADING – Ref TRO 005-45) :- NOTICE IS HEREBY GIVEN that Northumberland County Council propose to make the above-named Order under Sections 1, 2, 4, and paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of the Order, if made, will be to introduce No Waiting At Any Time parking restrictions (Double Yellow Lines) on Front Street Back Lane Bamburgh, High Street, Belford and Kingsfield Seahouses in the County of Northumberland.

The following restrictions are added to the Principal Order, North Northumberland (Northern) Area (Waiting & Loading) Composite Order 2011:

Addition – Waiting – Proscribed – At Any Time

7364	KINGSFIELD	SEAHOUSES	South	At its junction with Kings Street to a point 53 metres east of its junction with Kings Street
