COMPOSITE ORDER 2011 AMENDMENT NO 92 ORDER 2020

(WAITING AND LOADING – Ref TRO 011-92) :- NOTICE IS HEREBY GIVEN that Northumberland County Council propose to make the above-named Order under Sections 1, 2, 4, and paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of the Order, if made, will be to introduce additional ‘No Waiting at Any Time’ and ‘No Waiting’ parking restrictions in the Northburn Primary School/Horton Drive Area of Cramlington Town.

The following restrictions are added to the Principal Order, South East Northumberland Area (Waiting & Loading) Composite Order 2011
