NORTH NORTHUMBERLAND (NORTHERN) AREA (WAITING AND LOADING)
COMPOSITE ORDER 2011 AMENDMENT NO 46 ORDER 2020

(WAITING AND LOADING – Ref TRO 005-46) :- NOTICE IS HEREBY GIVEN that the Northumberland County Council propose to make the above-named Order under Sections 1, 2, 4, and paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of the Order, if made, will be to introduce No Waiting At Any Time parking restrictions (Double Yellow Lines) and Keep Clear parking restrictions (Yellow Zig-Zag Lines) in order to reduce congestion and improve road safety within the Osborne Road/Ladywell Road area of Tweedmouth (adjacent to Tweedmouth West First School).

The following restrictions are added to the Principal Order, North Northumberland (Northern) Area (Waiting & Loading) Composite Order 2011
