NOTICE OF PROPOSALS TO INTRODUCE ROAD HUMPS
(A1167 STAKEFRORD/BORMARSUND)

NOTICE IS HEREBY GIVEN that Northumberland County Council propose under Section 90A of the Highways Act 1980 as amended ("the Act") and all other enabling powers and after consultations with the chief of police in accordance with section 90C of the Act and those bodies or persons prescribed by the Highway (Road Humps) Regulations 1999 to introduce road humps in the form of eleven 65mm high speed cushions on the following roads and locations:
