

**NORTHUMBERLAND COUNTY COUNCIL  
ROAD TRAFFIC REGULATION ACT 1984  
(PONTELAND SCHOOL & LEISURE CENTRE  
PROHIBITION OF ENTRY RESTRICTIONS) ORDER 2020  
(TROM\_196)**

Northumberland County Council, in exercise of their powers under Sections 1, (2), (3) and (4) and Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act") and all other enabling powers, and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act, hereby make the following Order:

1.     (1)     This Order shall come into operation on the \*\*\*\* day of \*\*\*\*\* 2020 and may be cited as "Northumberland County Council (Ponteland School & Leisure Centre Prohibition of Entry Restrictions) Order 2020."
- (2)     The restrictions imposed by this Order shall be in addition to and not in derogation from any restriction or requirement imposed by any regulation made or having effect as if made under the Act or by or under any other enactment.
- (3)     Except where otherwise stated, any reference in this Order to a numbered article or schedule is a reference to the article or schedule bearing that number in this Order.
- (4)     The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
2.     Save as provided in Article 3, no person shall cause or permit any vehicle to enter and proceed on those lengths of highway detailed in the Schedule of this Order.
3.     Nothing in Article 2 shall make it unlawful to cause or permit any vehicle to enter and proceed on those length of highway detailed in the Schedule, if the vehicle is being used for fire and rescue, police, ambulance or special forces purposes.

**STATEMENT OF THE COUNCIL'S REASONS FOR  
PROPOSING TO MAKE THE ORDER**

The Order is necessary to prevent the risk of collisions at the exits of both car parks by prohibiting vehicles from entering via Callerton Lane, thereby improving road safety and the flow of traffic in the area.
