NORTH NORTHUMBERLAND (CENTRAL) AREA (WAITING AND LOADING)
COMPOSITE ORDER 2011 AMENDMENT NO 45 ORDER 2021

(WAITING AND LOADING – Ref TRO 003-45):- NOTICE IS HEREBY GIVEN that Northumberland County Council propose to make the above-named Order under Sections 1, 2, 4, and paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of the Order, if made, will be to extend 'No Waiting at Any Time' parking restrictions (double yellow lines) in Alnwick, with the aim of improving road safety in the area.

The following restrictions are added to the Principal Order, North Northumberland (Central) Area (Waiting and Loading) Composite Order 2011:-

Addition – Waiting – Proscribed – At Any Time

The following restrictions are deleted from the Principal Order, North Northumberland (Central) Area (Waiting and Loading) Composite Order 2011:-

Deletion – Waiting – Proscribed – At Any Time

003-025-002	LISBURN TERRACE	ALNWICK	North East	At its junction with Clayport Bank to a point 98 metres south east of its junction with Clayport Bank
