NOTICE IS HEREBY GIVEN that the Northumberland County Council propose to make the above-named Orders under Sections 1, 2, 4, 32, 35, 45, 46 and paragraphs 20 and 27 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of the Orders, if made, will be to introduce Traffic Regulation Orders to provide a Dual Use Limited Waiting Bay for Taxis and Bus Stand, No Waiting At Any Time Restriction (Double Yellow Lines) and School Keep Clear (Yellow Zig Zag Markings) restrictions adjacent to Stamfordham Primary School in the County of Northumberland.
