**STATEMENT OF THE COUNCIL'S REASONS FOR  
PROPOSING TO MAKE THE ORDER**

Central Parkway, Newbiggin-by-the-Sea

The Order is necessary to improve road safety in association with junction improvements at the B1334/U6519 Front Street, Central Parkway and Long Park in Newbiggin-by-the-Sea. A new refuge island is to be provided at the junction in order to improve crossing facilities for pedestrians and the additional parking restrictions are proposed to protect the vicinity from parked vehicles at all times.
