

**ROAD TRAFFIC REGULATION ACT 1984**

**SOUTH EAST NORTHUMBERLAND AREA (WAITING AND LOADING)**  
**COMPOSITE ORDER 2011 AMENDMENT NO 122 ORDER 2022**

(WAITING AND LOADING – Ref TRO 011-122):- NOTICE IS HEREBY GIVEN that Northumberland County Council propose to make the above-named Order under Sections 1, 2, 4, and paragraphs 20 and 27 of Schedule 9 of the Road Traffic Regulation Act 1984.

The effect of the Order, if made, will be to introduce 'No Waiting' parking restrictions (double yellow lines and single yellow lines) in Seaton Sluice, with the aim of improving road safety in the area.

The following restrictions are added to the Principal Order, South East Northumberland Area (Waiting and Loading) Composite Order 2011:-

**Addition – Waiting – Proscribed – At Any Time**
