Northumberland County Council (hereinafter referred to as "the Council") in exercise of their powers under Sections 32 and 35 and Part III and Part of IV Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984"), Part 6 of the Traffic Management Act 2004 ("the Act of 2004"), and after consulting with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 and of all other enabling powers hereby make the following Order:-
